### Admission Fee

An Admission Fee of \$200 is applied to each newly enrolling student or currently enrolled student who has not paid a Commitment Deposit on or before March 6<sup>th</sup> and who is currently enrolled in a class requiring a Commitment Deposit for the following school year.

### Tuition Refund Insurance

Mandatory annual tuition refund insurance of \$100 per family is due for enrolled families with initial 2009-2010 payment on May 1, and for new families with the completion of the Tuition Contract. (for full details see *Terms & Payment Requirements 2009-2010*)

### BC Ministry of Education Grant Credit

Most families qualify for the BCME Grant. All BC residents qualify. (see note 2 below)

Qualifying families will receive a tuition grant credit of \$1,800 for each Grade 1 – 12 student enrolled.

If eligible, this amount is deducted directly from the full tuition amount:

Grades 1 – 12: \$12,900 full tuition & fees - \$1,800 tuition grant credit = \$11,100 tuition & fees payable.

Note: The grant is prorated for attendance of less than 135 school days per school year up to May 15<sup>th</sup>.

### Sibling Discount

Individual student discount for families with more than one child in the school. (applies only to Kindergarten through Grade Twelve)

- Second Oldest Child: 10%
- Third Oldest Child: 20%
- Additional Children: 30%

### Early Payment Discount

Offered to BC Resident families: 2% of tuition when all contracted tuition & fees are paid in full on or before the first payment date. (minimum 5 month contract)

\* All amounts in Canadian Dollars, may be rounded to the nearest dollar and are subject to change without notice. Early Childhood Programs may vary according to enrolment requirements and actual fees for partial week programs will vary slightly.

<sup>1</sup> Tuition & Fees are all inclusive and no additional fees will be assessed through the school year. Tuition & Fees include:  
 1) tuition; 2) fees for school supplies, field trips and consumables; 3) fees for Community Development Programs & Events.  
 (see your family's Tuition & Fees 2009-2010 report for correspondent details for 1) Tuition; 2) TBase; 3) CommFee)

Tuition & Fees do not include:

- 1) ESL lessons; 2) required musical instruments other than flutes; 3) additional required remedial lessons or tutoring;
- 4) materials for extraordinary special projects; 5) generic High School supplies; 6) food for field trips.
