

After School Program Information and Rates

JULY 2016 NOTE:

Currently, we are taking names for registration in the order in which they have been received. We will start the formal registration process in early August once we have confirmed there is sufficient interest to make the program viable.

Program Description

The After School Program offers a warm and engaging environment consistent with the values of Waldorf education. The program is open to children in Kindergarten to Grade 6, with a limit of 3 kindergarten children per day. The Program Leader is Susana Cabellero. The Program Delivery Assistant is TBA. Program Manager is Peggy Tan. Program Administrator is Jennifer Breckon.

Program Hours

Monday to Wednesday & Friday: 3 to 6pm

Thursday: 2 to 6pm

Professional development days: 8:30 to 6pm***

The program runs on VWS school days and is not available on stat holidays, Christmas Break, Spring Break or during the summer months.

Program Costs (per child)

\$100 non-refundable, one time, registration fee.

(If more than one child is being registered you only pay this fee once)

Days per week:*

5 days: \$398/month**

4 days: \$338/month**

3 days: \$278/month**

2 days: \$188/month**

1 day: \$86/month

1 day (if on Thurs): \$108/month

Daily (Drop-In): \$40 /\$60 for early dismissal days (based upon availability; no guarantees; must be registered in program to be eligible)

Pro-D day rate: \$60/day or \$225 per week***

Late pick-up fee: \$25 for the first 15 minutes with an additional \$5/minute thereafter.

* The days of the week selected for part-time care cannot be changed without 1 month written notice and approval by Program Manager.

** Includes early dismissal days; does not include professional development weeks.

*** Availability of program during Pro-D Weeks is dependent upon sufficient enrolment.

This program is only available to students currently registered at Vancouver Waldorf School.

Notes:

1. Rates are pro-rated for the VWS school calendar and are not more than monthly fees charged by comparable local programs.
2. Registration is for the entire school year (September to June). There are no refunds for early pick-up or days missed due to illness or vacation. There are no discounts offered for multiple children from the same family.
3. One month written notice is required to withdraw from the program. For example, if you wish to cancel your registration for November 1, 2016 you must inform us in writing before or on October 1, 2016.
4. Unless written notice is provided, your registration will be considered active over the summer months (i.e. if you were registered in June 2017 you are automatically registered for September 2017). There are no monthly fees for July or August when the program is on break.
5. Monthly payments will be deducted by pre-authorized debit on the 1st day of every month.
6. No fee subsidy is offered for the After School Program. However, families may apply for the Child Care Subsidy offered through the provincial government, if they meet the requirements.
7. If you receive childcare subsidy you are responsible for paying the difference between the VWS Child Care rate and any subsidy you receive. If you are not eligible for subsidy, you are required to pay the full child care fees. It is a family's responsibility to ensure that their subsidy is current and all required paperwork is submitted to VWS. For more information, visit <http://www.mcf.gov.bc.ca/childcare/subsidy/>.
8. Program fees are reviewed yearly with a three months' notice for fee increases.
9. The program will run contingent on sufficient enrolment. Please register by August 1.
